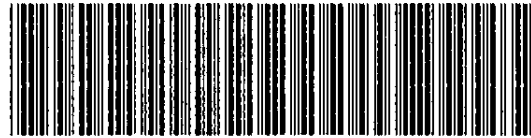

ARTICLE VI:

Byte to Bite, LLC is to be an at-will company.

ARTICLE VII:

The addition of members not listed in Article V of these Articles of Organization, will be admitted only with the unanimous consent of all members entitled to participate in management and upon such terms as are unanimously agreed to by all members entitled to participate in management, except as provided in Article X of these Articles of Organization.

ARTICLE VIII:

The addition of managers not listed in Article V of these Articles of Organization, will be admitted only with the unanimous consent of all members entitled to participate in management and upon such terms as are unanimously agreed to by all members entitled to participate in management, except as provided in Article XI of these Articles of Organization.

ARTICLE IX:

The transfer of management rights by any manager not also concurrently a member is prohibited.

ARTICLE X:

The transfer of membership rights, excluding distributional rights, is prohibited except upon death or incapacitation of the member. In such cases, transfer of management rights must be to a single individual selected from the following: spouse; parent; child or sibling. There is no restriction on the transfer of distributional rights.

ARTICLE XI:

The transfer of management rights by any managing member is prohibited except upon death or incapacitation of the managing member. In such cases, transfer of management rights must be to a single individual selected from the following: spouse; parent; child or sibling.


ARTICLE XII:

The business of Byte to Bite, LLC shall be conducted under the exclusive management of its managers, who shall have exclusive authority to act for Byte to Bite, LLC in all matters. The managers may from time to time designate certain members as officers to act for Byte to Bite, LLC in certain matters as specified by the Byte to Bite, LLC Operating Agreement.

ARTICLE XIII:

These Articles of Organization for Byte to Bite, LLC are to have an effective date of February 17, 2011.
