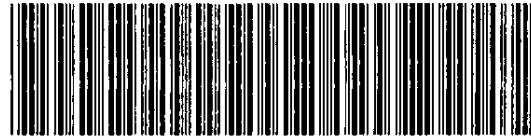



The undersigned, for the purpose of forming a Limited Liability Company pursuant to Florida Statutes 608, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "BachScholar Publishing, LLC."

ARTICLE II — Address:

The mailing address and street address of the principal office of the Company is 5949 15th Avenue S., St. Petersburg, FL 33707.

ARTICLE III — Registered Agent:

ARTICLE IV — Management:

The purposes for which this limited liability company is organized is to engage in any activity or business permitted under the laws of the United States and of Florida.


ARTICLE V — Limitation on Liability of Members:




