ARTICLES OF ORGANIZATION

OF

ARTICLE IV - REGISTERED OFFICE AND AGENT


The name and street address of the registered agent of the Company in the State of Florida is Daniel R. Lozier, 24 West Chase Street, Pensacola, Florida 32502.
