The Limited Liability Company shall have seven (7) members initially. The names of the members and their respective interests in the Limited Liability Company are as follows:

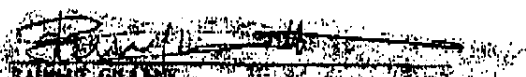

Additional members may be admitted at the discretion of Rahim T. Gillani, or his heirs at law or as designated, whichever the case may be.

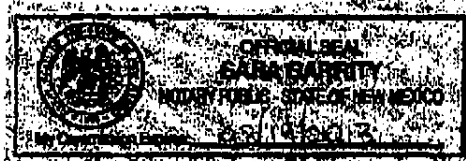
