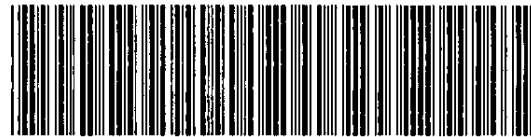



**ARTICLES OF ORGANIZATION OF
HARVEY CAREERS, LLC**

Article I

The name of the limited liability company ("Company") is HARVEY CAREERS, LLC.

Article II


Article VII
