ARTICLES OF ORGANIZATION OF HARVEYCAREERS, LLC

Article I

The name of the limited liability company ("Company") is HARVEYCAREERS, LLC.

Article II

The mailing address of the Company is P.O. Box 750, Pierson, Florida 32180 and street address of the Company's principal office is 1616 Caroline Drive, Pierson, Florida 32180.
