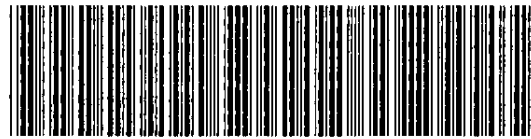

**ARTICLES OF ORGANIZATION**

**ARTICLE I - NAME**

The name of the Florida limited liability company shall be ELLIOTT FAMILY TRUST, LLC.


