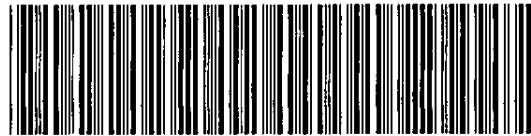

1. The name of the Company is Sarasota Clinical Research, LLC.
