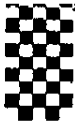

**ARTICLES OF ORGANIZATION
OF
KELLEY TITLE, LLC**

**ARTICLE I
Name**

The name of this limited liability company is **KELLEY TITLE, LLC**.

**ARTICLE II
Existence**

This limited liability company shall have perpetual existence.

**ARTICLE III
Purpose**

This limited liability company is created for any lawful purpose (except that special statutes for the regulation and control of specific types of businesses shall control when in conflict herewith) and for the benefit of its members and such business as may be agreed on by its members.

**ARTICLE IV
Registered Agent and Address**

The mailing and street address of the principal office of the limited liability company shall be 5680 W. Cypress Street, Suite A, Tampa, Florida 33607 and such other place or places as may be designated by the Manager from time to time. The name and address of the initial registered agent of the limited liability company shall be Pennington, Moore, Wilkinson, Bell & Dunbar, P.A., 2701 North Rocky Point Drive, Suite 900, Tampa, Florida 33607.

**ARTICLE V
Initial Members**

The initial members of the limited liability company shall have the right to admit additional members upon the following terms and conditions:

1. Said members must wish to associate themselves with the limited liability company for the business purposes stated;

3. The death, retirement, resignation, expulsion, bankruptcy or dissolution of a member of this limited liability company, or the occurrence of any other event which
