**ARTICLES OF ORGANIZATION
OF
JRAG INVESTMENTS, LLC**

1. Name. The name of this limited liability company is **JRAG INVESTMENTS, LLC**, a Florida limited liability company (the "Company").
2. Duration. The Company's existence shall commence on the date these Articles of Organization are filed and shall thereafter have perpetual existence.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
4. Place of Business. The mailing and street address of the Company's principal office is 5002 West Dante Avenue, Tampa, Florida 33629, ATTENTION: Amir Glogau.
5. Registered Agent and Office. The initial registered office of this corporation shall be located at 401 East Jackson Street, Suite 1700, Tampa, Florida 33602 and the initial registered agent of this corporation at such office shall be Joseph Rugg. The Company shall have the right to change such registered agent and such registered office from time to time, as provided by Florida law.
6. Contributions to the Company. No cash or property (other than cash) has been contributed to the Company by its members at this time. No contributions have been agreed upon.
7. Additional Members. Additional members to the Company may be admitted, but only upon the consent of the members of the Company at the time admission is sought.
8. Termination of a Member's Membership. The death, retirement, resignation, expulsion, bankruptcy, or dissolution of any member or the occurrence of any other event that terminates the continued membership of any member shall not cause the Company to be dissolved, and upon the occurrence of any such event, the Company shall be continued without dissolution.
9. Management of the Company. The Company shall be manager-managed in accordance with the operating agreement adopted by all of the members. The initial managers shall be **AMIR GLOGAU** and **JOSEPH RUSSO**. Until and unless changed in accordance with the operating agreement, each manager shall have full power and authority to act for and on behalf of the Company, including, without limitation, to enter into contracts, open and close bank accounts, incur and pay debts and expenses, file papers with the Internal Revenue Service, and engage consultants, managers, professionals, and other advisors, and all persons may rely on these Articles of Organization to deal directly with these named individuals and the persons they designate on all matters relating to the Company.
