AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF YALAHA BAKERY OF ORLANDO LLC

ARTICLE I - NAME

The name of the limited liability company shall be YALAHA BAKERY OF ORLANDO LLC ("company").
