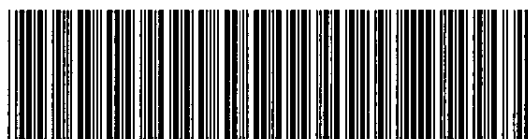

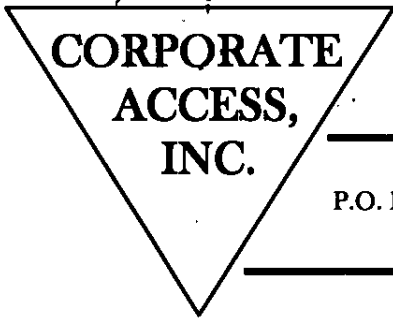

The undersigned organizer hereby forms a professional service Limited Liability Company under Chapters 608 and 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the professional service Limited Liability Company ("Company") shall be **Marianne Geraci, M.D., PLLC**.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS


