**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
AO BLACK DIAMOND GOLF HOLDINGS, LLC**

The Articles of Organization of AO Black Diamond Golf Holdings, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on March 7, 2011 under Document Number L11000028100. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the Company is AO Black Diamond Golf Holdings, LLC.

ARTICLE II - PRINCIPAL OFFICE

The mailing address and the street address of the principal office of the Company is 642 Interlachen Avenue, Winter Park, Florida 32789.

ARTICLE III - REGISTERED OFFICE AND AGENT

ARTICLE IV - MANAGEMENT

The Company is a member-managed limited liability company and the name and address of the member of the Company is Raymond L. Gellein, Jr. at 642 Interlachen Avenue, Winter Park, Florida 32789.
