**ARTICLES OF ORGANIZATION OF

The undersigned, being authorized to execute and file these Articles, hereby forms a limited liability company under the laws of the State of Florida to be known as AQUA PUBLIC ART, LLC (the "Company").

ARTICLE I — Name

The name of the Company is AQUA PUBLIC ART, LLC.

ARTICLE II — Address

ARTICLE III — Purpose

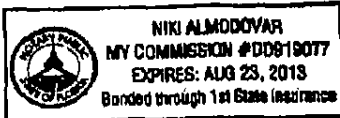
