Principal Office

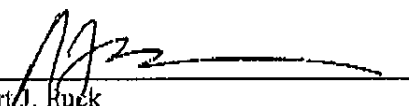

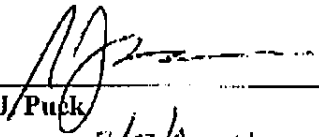
