ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statues Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 10 - INDEMNIFICATION

All references in these Articles of Organization to "director", "member", "employee" and "agent" shall include the heirs- estates executors, administrators and personal representatives of such persons.
