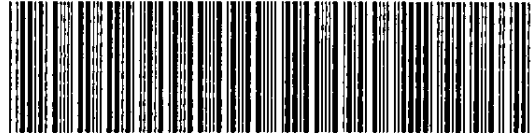




1. **Name.** The name of the limited liability company is Goldon Group Holdings, LLC.


