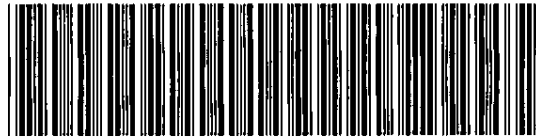

**Original Articles of Organization filed with the

**ARTICLE I
Name**

The name of the limited liability company is Newsvision LLC (hereinafter called the "Company").

**ARTICLE II
Principal Office**
