ARTICLE 1 - NAME

The name of the limited liability company shall be **MEDIAFISH LLC** ("Company").

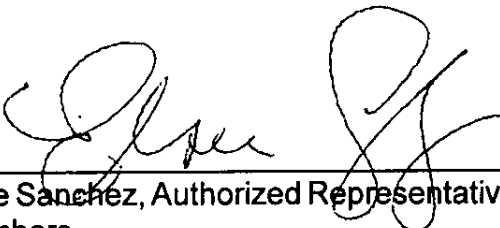

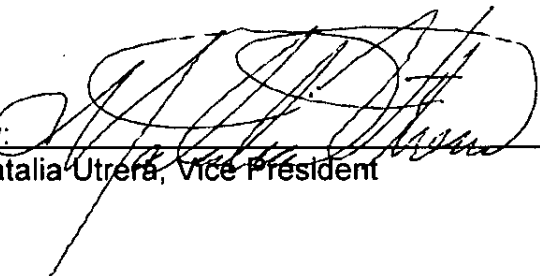
