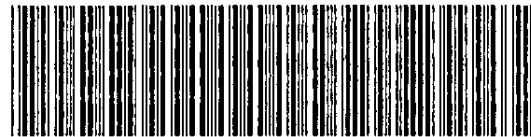

Address


