The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Relate Labs, LLC ("Company").



The existence of the Company shall commence at 12:01 A.M. on March 10, 2011.




