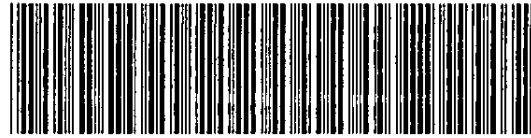



This limited liability company shall have a perpetual existence, unless dissolved according to law, effective as of the 9th day of March, 2011.


