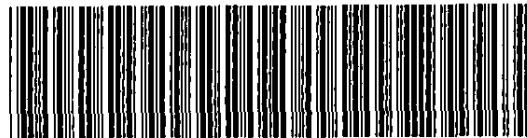

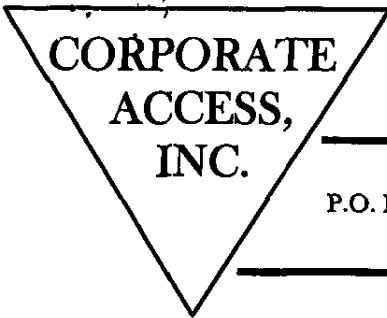

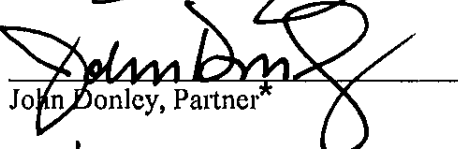

ARTICLE IV - MANAGEMENT

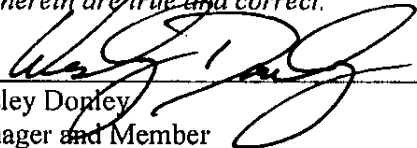
