ARTICLES OF ORGANIZATION

ARTICLE I. NAME.

The name of this limited liability company is Converse Property Services, LLC and the principle place of business and mailing address of the Limited Liability Company is 2927 SE 10th Avenue, Cape Coral, FL. 33904

ARTICLE II. DURATION.

This limited liability company shall exist perpetually; beginning on the date these Articles of Organization are filed with the Florida Department of State.
