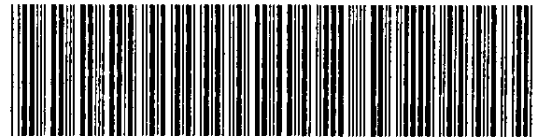

MANAGEMENT


