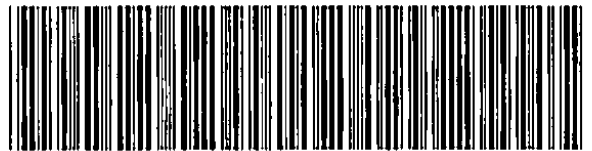

Please accept this letter as formal notification that I am resigning from my position as a Managing Member at South Tampa Auto and Tire LLC.


My last day will be Tuesday, December 31, 2019.


