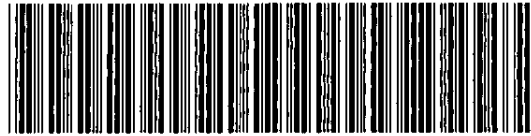

ARTICLE 1 - NAME

The name of the limited liability company shall be COLONEL ANGUS, LLC, ("Company").

ARTICLE 2 - ADDRESSES

The principal place of business of the Company in Florida shall be 11341 NW 29th Manor, Sunrise, FL 33323. The mailing address of the Company shall be 11341 NW 29th Manor, Sunrise, FL 33323.

ARTICLE 3 - EFFECTIVE DATE

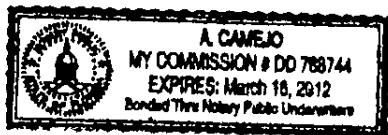


