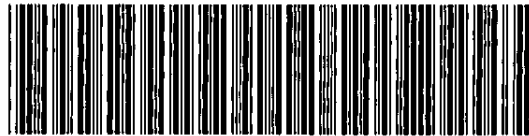

The name of this limited liability company shall be: **SECURED DEBT INVESTMENTS BALTIMORE, LLC.**


**ARTICLE II**
