**ARTICLES OF ORGANIZATION
OF
HH SALES LLC.**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby adopt the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be HH Sales LLC. ("Company").

ARTICLE II - ADDRESS

The principal place of business of the Company in Florida and its mailing address is: 1832 Foster Drive, Jacksonville, Florida 32216.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State and shall continue perpetually, unless terminated in accordance with the Company's Operating Agreement or by the unanimous written consent of all of the Members.

ARTICLE IV - PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful activity or business for which a limited liability company may be organized under the laws of the State of Florida and the United States. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The Company designates 1832 Foster Drive, Jacksonville, Florida 32216, as the street address of the initial registered office of the Company and Mark H. Tolleson as the Company's initial registered agent at that address to accept service of process within this State.

ARTICLE VI - ADMISSION OF NEW MEMBERS

No additional Members shall be admitted to the Company except with the unanimous written consent of all the Members of the Company and upon such terms and conditions as shall be determined by all the Members. A Member may transfer his, her or its interest in the Company as set forth in the Operating Agreement of the Company,

but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a Member unless all the other Members of the Company other than the Member proposing to dispose of his, her or its interest approve of the proposed transfer by unanimous written consent.

ARTICLE VII - MANAGEMENT

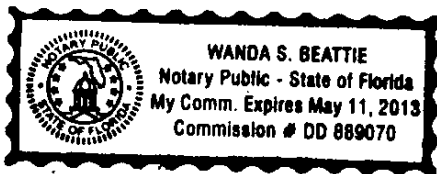
The Company shall be conducted, carried on and managed by no fewer than one (1) Manager, who shall be elected annually by the Members of the Company in accordance with the Operating Agreement of the Company. Such Manager shall also have the rights and responsibilities described in the Operating Agreement of the Company. The name and address of the initial Manager is: Mark H. Tolleson at 1832 Foster Drive, Jacksonville, Florida 32216. Such Manager shall serve until the first annual meeting of Members or until his successor or successors are duly elected and qualified.

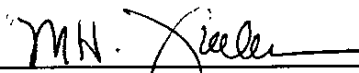
