These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is FOUNDATIONS FINANCIAL PARTNERS, LLC.

ARTICLE II - MAILING ADDRESS

The mailing address and street address of the principal office of FOUNDATIONS FINANCIAL PARTNERS, LLC is 2572 W. State Road 426, Suite 2056, Oviedo, FL 32765.

ARTICLE III - DURATION

The period of duration for FOUNDATIONS FINANCIAL PARTNERS, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

ARTICLE IV - REGISTERED AGENT & OFFICE

The name of the initial registered agent is The Law Offices of Hoyt & Bryan, LLC. The street address of the initial registered agent is 254 Plaza Drive, Oviedo, FL 32765.

ARTICLE V - ADDITIONAL MEMBERS

Additional members to the Company may be admitted, but only if all the current member agrees to the admission of the additional members and to the terms of admission.

ARTICLE VI - TERMINATION OF MEMBERSHIP

If a member of the company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in FOUNDATIONS FINANCIAL PARTNERS, LLC, the remaining members may, by unanimous agreement, continue the business of FOUNDATIONS FINANCIAL PARTNERS, LLC.

ARTICLE VII - MANAGEMENT

FOUNDATIONS FINANCIAL PARTNERS, LLC is to be managed by its Member and the name and address of the individual who will serve as the Managing Member is:

The Members shall have the power to adopt, alter, amend, or repeal regulations of FOUNDATIONS FINANCIAL PARTNERS, LLC.
