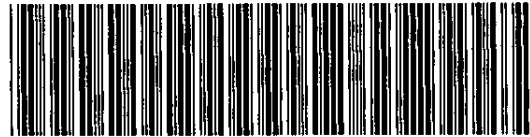


1. The name of the Company is Physicians Care Plus of Orlando, LLC.
