**AMENDMENT TO ARTICLES OF ORGANIZATION**

WHEREAS, the Members of 900 DIXIE, LLC., a Florida Limited Liability Company, have approved and adopted this 3 day of June, 2015, subject to the approval thereof by the Secretary of State of Florida, the following Amendment to the Articles of Organization for the purpose of changing the Manager and Registered Agent Address of the Company.

WHEREAS, the prior Manager of the Company, Arthur F. Long, Jr., is now deceased, and the Registered Agent address is no longer accurate;

NOW THEREFORE, it is provided that Article IV and Article V of Articles of Organization shall be amended, and that subsequent to said amendments, that Article IV and Article V shall provide as follows:
