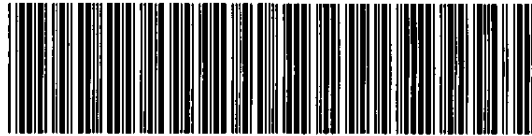




ARTICLE V – GOVERNED BY OPERATING AGREEMENT
