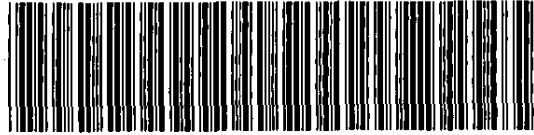

Articles of Organization
of
MOZ CAUSE, LLC

ARTICLE I
Name

The name of the Limited Liability Company is Moz Cause, LLC.

ARTICLE II
Address

ARTICLE IV
Management

Moz Cause, LLC, is to be managed by Todd Amacker, its sole member, and is, therefore, a member-managed company.

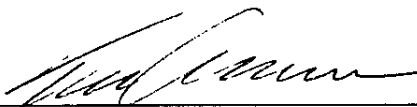
ARTICLE V
No Private Inurement

No part of the net earnings of Moz Cause, LLC, shall inure to the benefit of, or be distributable to, its members, officers, or other private persons, except that the Limited Liability Company shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles. No substantial part of the activities of the Limited Liability Company shall be the carrying on of propaganda or otherwise attempting to influence legislation (except that, if the Limited Liability Company so elects, it may make such expenditures in conformity with Section 501(h) of the Internal Revenue Code) and the Limited Liability Company shall not participate in or intervene in (including publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provision of these Articles, the Limited Liability shall not carry on any other activities not permitted to be carried on: (a) by a Limited Liability Company exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a Limited Liability Company, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law).

ARTICLE VIII
Distribution of Assets Upon Dissolution or Liquidation

Upon the dissolution of the Limited Liability Company, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the LLC is then located, exclusively for such purposes or to such organization

or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
