Notwithstanding any other provision of these Articles, the Limited Liability shall not carry on any other activities not permitted to be carried on: (a) by a Limited Liability Company exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a Limited Liability Company, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law).

ARTICLE VIII Distributino of Assets Upon Dissolution or Liquidation
