ARTICLES OF ORGANIZATION 11 MAR 30 PM 3 21 OF ADVENIR @ HIGHLAND PARK GP, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I NAME

The name of the limited liability company is Advenir@Highland Park GP, LLC (the "Company").

ARTICLE II MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 17501 Biscayne Boulevard, Suite 300, Aventura, Florida 33160.

ARTICLE III REGISTERED AGENT AND OFFICE

The name and street address of the initial registered agent of the Company in the State of Florida is Torres Law, P.A., 17501 Biscayne Blvd., Suite 470, Aventura, Florida 33160.

ARTICLE VII MANAGEMENT; INITIAL MEMBER

The Company shall be a member-managed limited liability company and shall be managed in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the business and operations of the Company, not inconsistent with Florida law or the Articles. The initial member and initial Managing Member of the Company shall be Advenir, Inc., 17501 Biscayne Boulevard, Suite 300, Aventura, Florida 33160.

ARTICLE VIII

AMENDMENT

The Articles may be amended only in accordance with the Operating Agreement.
