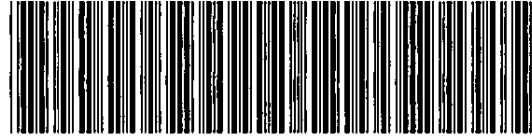



The name of the Company is WAVE OF IDEAS, LLC.


ARTICLE II
