ARTICLE I

The name of the limited liability company (referred to hereinafter as the "Company") is as follows:

ARTICLE VI - MANAGEMENT

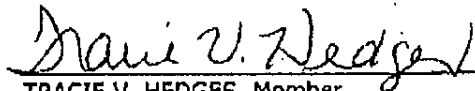
