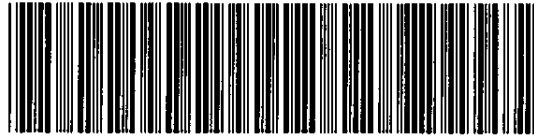

The name of this limited liability company shall be: **RADE LLC.**

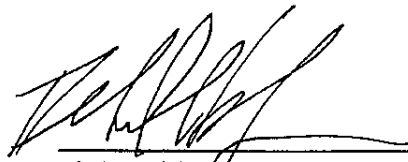
ARTICLE II

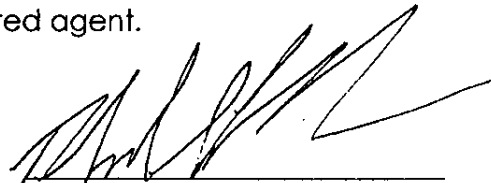
