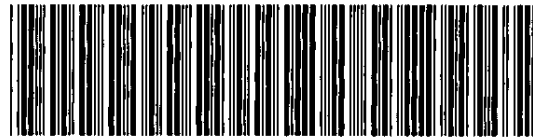

ARTICLES OF ORGANIZATION
OF
PDL NAPLES, LLC,
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, pursuant to Section 608.407, Florida Statutes, adopts the following Articles of Organization for such Limited Liability Company:

ARTICLE I
NAME

The name of this limited liability company is PDL NAPLES, LLC, referred to in these Articles of Organization as the "Company".

ARTICLE II
PRINCIPAL OFFICE, REGISTERED OFFICE AND AGENT

ARTICLE X
RELATIONSHIP OF ARTICLES OF ORGANIZATION TO

If a provision of these Articles of Organization differs from a provision of the Company's Operating Agreement, then, to the extent allowed by law, the Operating Agreement will govern.


