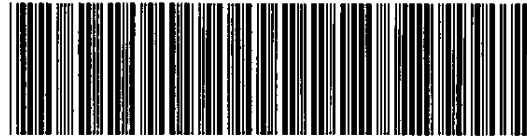


**ARTICLES OF DISSOLUTION FOR PBS INLET, LLC.**  
**A FLORIDA LIMITED LIABILITY COMPANY**

1. The name of the Limited Liability Company is PBS Inlet, LLC.
2. The Articles of Organization were filed on April 7, 2011, and assigned Document Number: L11000041941.
3. The delayed effective date for the dissolution is October 24, 2014.
4. Pursuant to Florida Statute Section 605.0701(1), Article 10.1 (c), states:  
  
"The company shall dissolve only upon the occurrence of one or more of the following:  
  
(c) The sale or other disposition of all or substantially all of the company's assets and properties and the collection of all notes received in connection with such sale or other disposition."

All of the foregoing having occurred, this Company is dissolved, has ceased conducting business and continues solely for the purpose of winding up its affairs in accordance with Florida Statute Section 605.0709.
