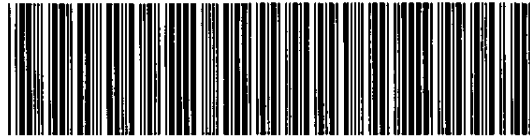

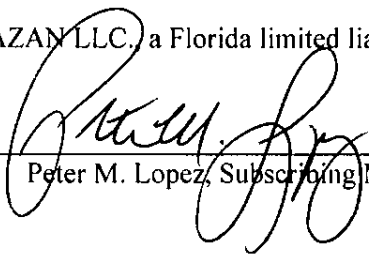
**ARTICLES OF AMENDMENT

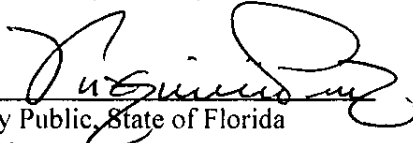

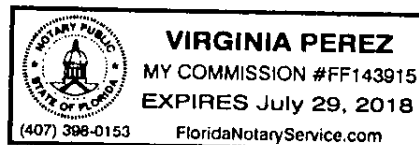
