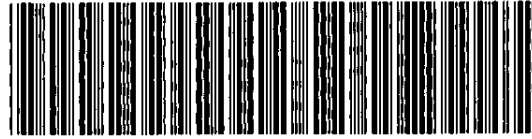

SECOND: The following amendment to the Articles of Organization of the Company was duly adopted by the Company:

1. H. Hunter White, III was erroneously named in the Articles of Organization as an initial member of the Company. Accordingly, Article IV of the Articles entitled "Management" is hereby deleted in its entirety and the following inserted in lieu thereof, to-wit:

**"ARTICLE IV
