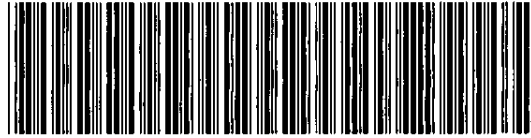


ARTICLE IV


