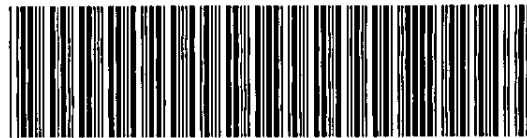

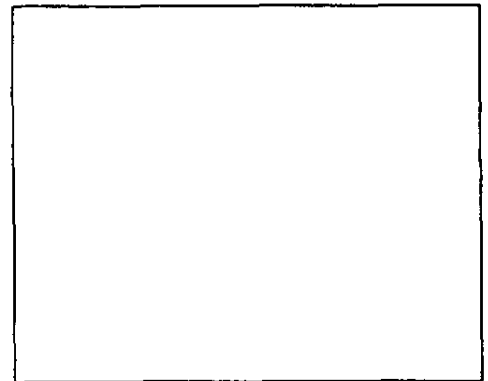

NAME**


The name of the limited liability company shall be J & A SELLERS, LLC, (the "Company").
