This Amendment of the Articles of Organization of **Haven Medical Group, LLC**, a Florida limited liability company (the "Company"), is adopted and filed pursuant to Section 605.0202, *Florida Statutes*.

FIRST: The present name of the Company is **Haven Medical Group, LLC**, but the name of the Company is changed pursuant to this Amendment. The Company's Document Number is L11000044790.

SECOND: The Company's Articles of Organization were filed on April 14, 2011.

THIRD: The text of the amendment to the Articles of Organization is as follows:

1. **Article I** of the Articles of Organization, entitled "**Name**," is amended in its entirety to read as follows:

"The name of the Company is **NCF Support Services, LLC**."

FOURTH: The foregoing amendment was duly approved on August 28, 2024 by the board of directors of North Central Florida Hospice, Inc. and the board of directors of SantaFe HealthCare, Inc., in accordance with the Company's Articles of Organization.
