**ARTICLES OF ORGANIZATION  
OF  
J INVESTMENT, LLC**

The undersigned, as the authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I**

**NAME**
