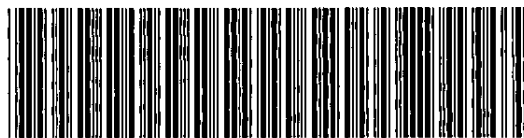

The name of this limited liability company shall be: **BLUE SKIES 2011, LLC**


ARTICLE II


