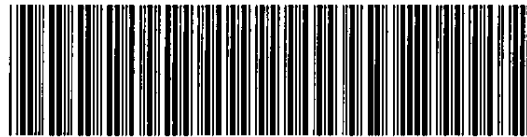





The company is to be managed by a member and the name and address of the managing member is:


