THIRD: The dissolution was approved on May 16, 2011.

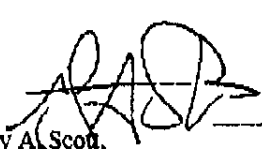
FOURTH: The Limited Liability Company's dissolution pursuant to Section 608.441, Florida Statutes has occurred as a result of a written consent of the members of the Company.

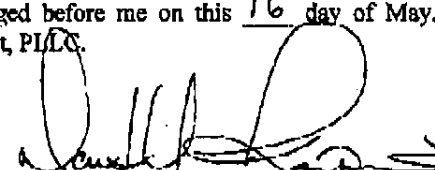
